In addition, Dr. Jones is a member of the North American Spine Society and the Society for Minimally Invasive Spine Surgery.

Orthopedic surgery or orthopedics is the branch of surgery that deals with conditions involving the musculoskeletal system. An orthopedic surgeon, like Dr. Jones, offers care to patients suffering from problems associated with the joints, bones, muscles, tendons, and ligaments.
