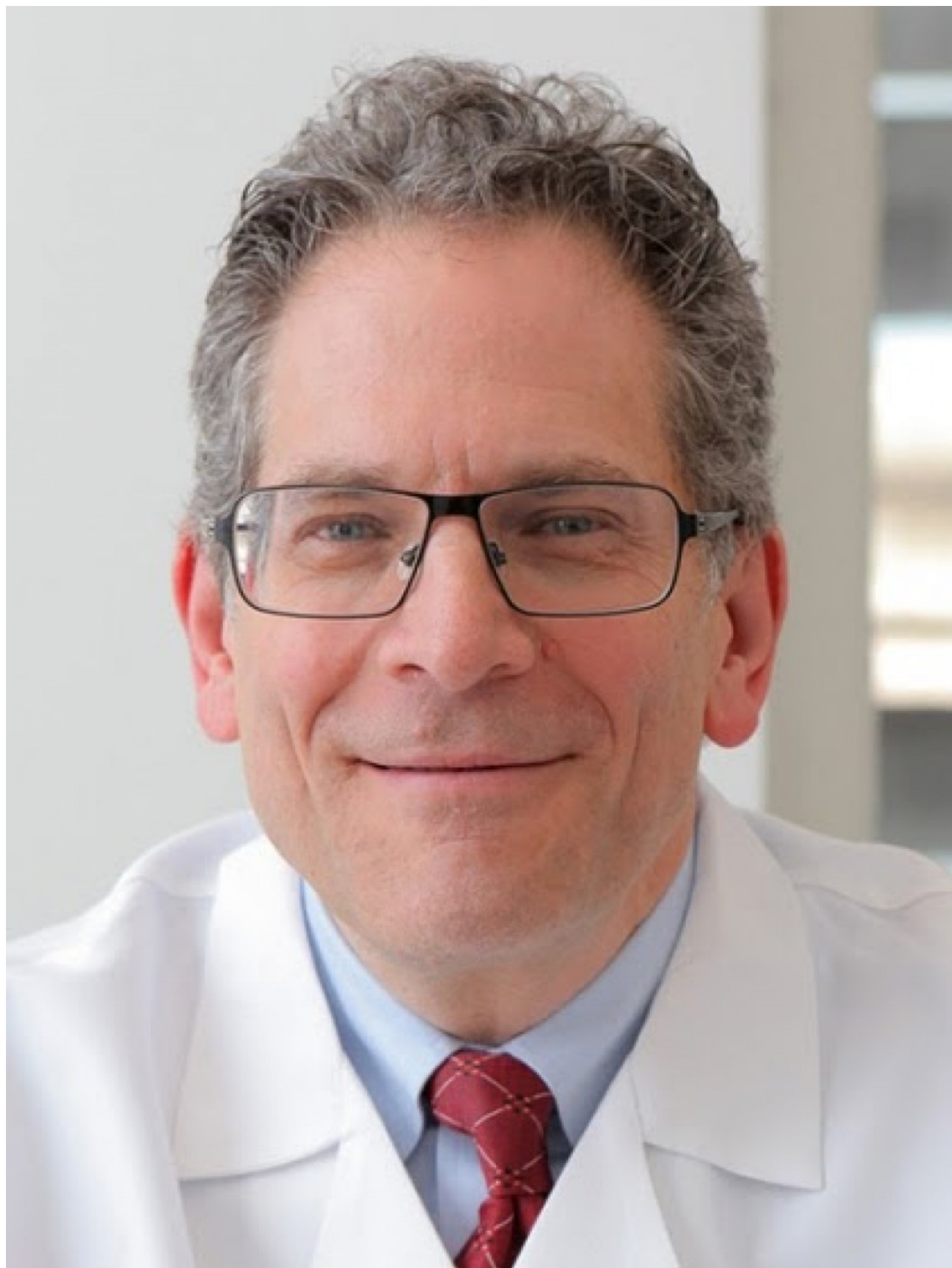


Charles T. Silvera, MD, an Internist with Horizon Medical Group
