who is a U.S. resident, maintain a GPA of 3.0 or higher from the time of the submission of the application until the scholarship is issued, and must be able to prove that they are enrolled full time at an ABA accredited law school at the time the scholarship award is issued. Part-time applicants are not eligible. Additionally, all applicants must submit: an official transcript reflecting current academic status, proof of enrollment or acceptance into an ABA accredited law school and a personal essay with no less than 650 words. Completed applications and all requested information must be emailed to **suarezandmonterofax@gmail.com** by **December 1, 2020**, in order to be considered timely.
