
## Powerful African-American Memoir Debuts as #1 New Release

## Attorney Carlos E. Moore's New Powerful Memoir Debuts as #1 New Release

"I could not have that flag displayed behind me as I attempted to administer justice," Carlos E. Moore, co-author and one of The Five Brothers, states as he recounts his first day of becoming the first African-American Municipal Judge Pro Tem for the city of Clarksdale, Mississippi. Carlos ordered officials to remove the state flag from his courtroom as it did not represent justice for people of color. His powerful leadership in fighting for justice is evident throughout his new compelling memoir, recounting his life as a Black man in a world meant to act against him.

Carlos E. Moore describes the now-retired Mississippi state flag that disturbingly held the Confederate emblem as representing "the subjugation of my people, lynchings, murder, and enslavement." He continued to state, "We're supposed to honor that flag in spite of what it stands for? My little daughter is expected to honor that flag? No." Mississippi became the last state to retire the flag. From finding out heart-wrenching news at only 8-years-old to opening his own law firm, Carlos captivates readers through his journey in becoming a successful black man in America.

Carlos E. Moore, a Moss Point, Mississippi native, is a Civil Rights Attorney, President-Elect of the National Bar Association, and managing partner of The Cochran Firm - Mississippi Delta. In July of 2017, Carlos became the first African-American Municipal Judge Pro Tem for the City of Clarksdale, Mississippi. In May of 2020, he became the first African-American Municipal Judge Pro Tem for the City of Grenada, Mississippi. On his first day, he ordered officials to remove the Mississippi State Flag with the Confederate emblem from his courtroom because it did not represent justice for people of color. His continued efforts in having the state flag retired was finally a success on November 3rd, 2020 when Mississippi approved its new state flag with a magnolia blossom in the center.

Carlos is very active in several bar associations (ie. National Bar Association (NBA), American Bar Association, etc) as well as his community (ie. 100 Black Men of Grenada, Kappa Alpha Psi Fraternity, Inc, etc). In 2012, Moore was named a Top 100 White House Fellows Regional Finalist, also named Young Lawyer of the Year by the NBA. In September of 2020, African Leadership Magazine named Carlos one of the Top 100 Most Influential African-American Leaders in the United States. Married to the former Natalie Herrington of Grenada, the Moore's are the proud parents of one daughter, Avery Nicole, and active members of the Abundant Life Assembly in Grenada where Carlos serves as General Counsel.
