With over four decades of experience, Dr. Sharp is board-certified in pediatrics and neonatal-perinatal medicine by the American Board of Pediatrics (ABP). The ABP exists to promote excellence in medical care for children and adolescents. Certification represents dedication by pediatricians, pediatric subspecialists, and pediatric trainees to the highest level of professionalism in patient care.

Neonatology is a subspecialty of pediatrics that consists of the medical care of newborn infants, especially the ill, or premature newborns. It is a hospital-based specialty and is practiced in neonatal intensive care units. Neonatologists generally diagnose and treat newborns with conditions such as breathing disorders, infections, and birth defects, as well as coordinating care and medically managing newborns born prematurely, critically ill, or in need of surgery.
