"The knee-jerk reaction is to hire the lawyer first, and now people are wiser. They want to work with a divorce coach. Many people are practicing, but there's no place for them, a space specifically geared to divorce coaches for professional development, growing their business, and connecting with other divorce coaches. Divorce Coaches Academy is that space," she explained. On Wednesdays, coaches can enroll in the Brown Bag Series, four lunch gatherings for 45 minutes each. May's first Brown Bag Series will be *Get Out of Your Head, Creating More Wins in Your Divorce Coaching Practice*. The series is \$79. The Academy also has an upcoming Happy Hour: *Networking and Group Discussion on Self-Care* for the Divorce Coach for \$10. For those seeking to hone their coaching skills, the Academy offers a small group Professional Mentorship Program that will be six 90-minute hands-on sessions led by Academy Master Educator, Susan Kiernan, offered at \$297.
