Amazon provides a system for feedback and complaints filed by customers. If you are unhappy with a transaction or you have a complaint, it will be delivered to the relevant customer care. Here are some of the main reasons that a user can choose Amazon Suspension Appeal Service:

* [Amazon Suspension Appeal](#) is the most popular service which can be availed by customers who are unhappy with some of their Amazon healthcare service charges. When you are not happy with any of the health service charges, you can appeal and request a refund. Amazon will then send you a letter that informs you that you have requested a refund and that you have until the end of the day of the date on which you appeal, to either cancel your appeal or send the evidence that will substantiate your appeal. This appeal must be sent through registered mail so that you can track it and receive a reply from Amazon. The timeframe provided is usually not a lot of time and thus, you have to ensure that you appeal before the deadline.

* Amazon suspension Appeal is the best solution that you can choose to file a complaint against the adverse health service charges decision made by the Amazon department. This is because the benefit decision made by the department cannot be appealed unless there are three reasons for the decision. The most important being, you are not eligible to appeal if you do not have enough proof for the benefit decision.

* If you have not received any response from the Amazon service, then it's advisable to file **Amazon Suspension Appeal**. Once you file the appeal, you should wait for a reply from the Lord Chief Justice. If the decision is upheld, then you have an opportunity to present your case before the tribunal members. The first three arguments presented by the claimants are allowed before the tribunal. However, if you have failed to make any persuasive argument or you fail to submit sufficient evidence for the claims, then the case is thrown out. Hence, it is important to provide appropriate supportive documents before submitting your complaint.

* Amazon informed The customer service department of Amazon about the complaint and provided written notification to the customer. The service department then reviews the complaints and sends the complaint to the Lord Chief Justice, who is responsible for the appeal process. On receiving the complaint, the lord chief justice will send his decision within three months. He may also request the store to appeal before the Employment Tribunal within three months. The applicant then has to contact the tribunal within three months and prove that the appeal is justified before they are accepted.

The above process is clearly described in the terms and conditions of the Amazon services agreement. Hence, all the applicants must understand the entire process well before submitting the appeal form noa1. Amazon reserves the right to transfer the appeal or termination of the contract based on grounds of failure to comply with these terms and conditions. If the applicant is still unsatisfied with the decision of the tribunal, then he may request for a re-hearing before the Employment Tribunal.
