Opted after 24 hours, then cancellation fees are charged and passengers must pay cancellation fees to process the cancellation.

Does Spirit allow flight changes?

How to Change Flights on Spirit Airlines: Spirit Airlines Flight Change Policy

In accordance with Spirit Airlines' flight change policy, airline passengers can change their flight (free) within 7 days to 24 hours of purchase. However, the reservation must be made 7 days prior to the scheduled departure of the Spirit flight. Additionally, passengers must pay the fare difference between their original reservation and the next flight. If the passenger cancels their Spirit Airlines flight ticket after 24 hours, then the airline's flight ticket will be applied, which can range from \$ 0 to \$ 110. Passengers traveling with Flex fare can change their flight reservation without paying anything one time only. But if they plan to cancel, then they will have to pay Spirit Airline's flight cancellation fee.
