Tan Sri Dr. Chin is also the Chief Executive Officer and Director of QMIS TBS Capital Group Corp Ltd, a company that is currently seeking a listing on Nasdaq Global Market.

Tan Sri Dr Chin graduated from the University of Hull in the United Kingdom with a Master in Finance Degree. In 1994, Tan Sri Dr. Chin earned a Master of Business Administration (MBA) Degree from the Irish University Business School. In 2020, Dr. Chin was awarded a Doctor of Philosophy in Financial Management by the North Borneo University College.

On July 17, 2014, Dr. Chin was awarded the title of Dato' Sri from the Sultan of Pahang, Kuala Lumpur, Malaysia, which is the highest state title conferred by the Ruler of Malaysia to the most deserving recipients who have contributed greatly to the nation or state.

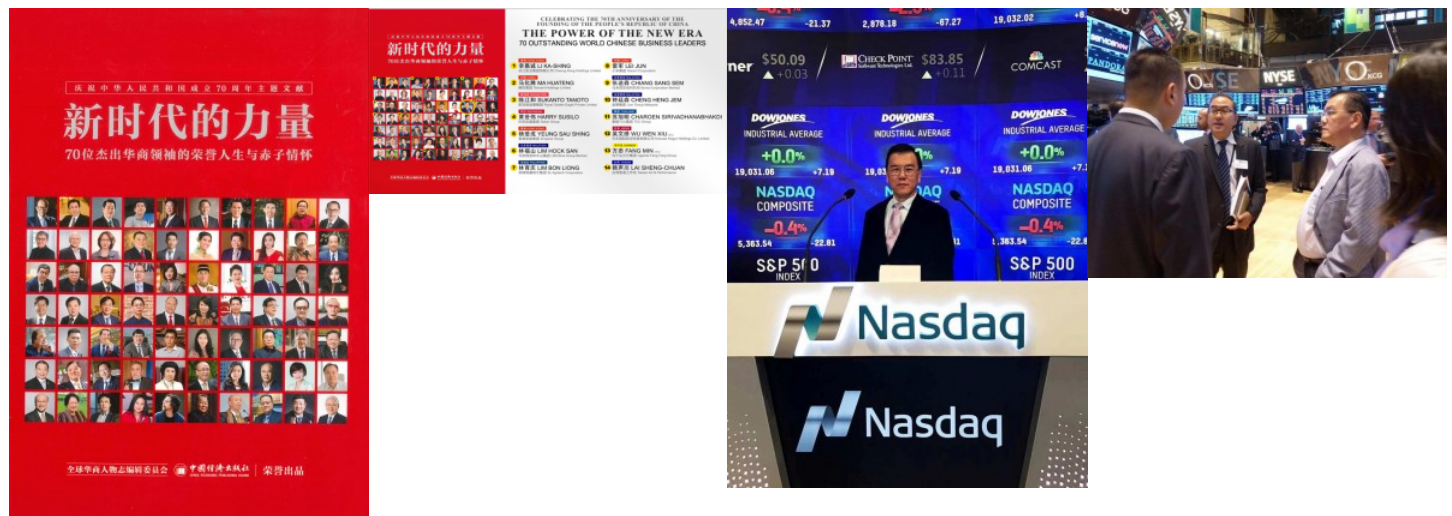
In 2019, Tan Sri Dr. Chin Yung Kong was listed as one of the 70 Outstanding Chinese Business Leaders in the book published by the Global Chinese Merchants and Chinese Economic Publishing House in conjunction with the 70th Anniversary of the founding of the People's Republic of China, The Power of the New Era: The Honorary Life and the Feelings of a Naïve Child of 70 Outstanding Chinese Business People.

Prior to 1995, Dr. Chin was a practicing auditor and Certified Public Accountant (CPA) with Foo Kon & Tan in Singapore. From 1995 to 2002, Dr. Chin was financial controller for the Kuok Group Company (which belongs to Robert Kuok, the richest man in Malaysia, also known as the "Sugar King") in China. After leaving the Kuok Group, Tan Sri Dr. Chin decided to venture out on his own and founded the QMIS Financial Group. Since 2002, Tan Sri Dr. Chin has been devoting most of his time advising Chinese clients on financial restructuring, pre-audit evaluation before going public, pre-IPO investment strategies, and the process of going public in the United States.

Tan Sri Dr. Chin has assisted and consulted over 24 companies and guided them to listing and initial public offerings (IPO) on several platforms around the world including Nasdaq, the Stock Exchange of Hong Kong, and stock exchanges in China. One of his most memorable companies was Shineco (Stock code: TYHT), which sold at the IPO price of USD4.50 and started at a listing price of USD 8.00 and raised to a high of USD 34.88 before closing at the price of USD28.00 on the first day of listing.

Another company listed on Nasdaq where Tan Sri Dr. Chin is the 3rd largest shareholder is Nisun International Enterprise Development Group Co Ltd (stock code: NISN). Tan Sri Dr. Chin holds 1,200,000 shares which constitute 5.84% of NISN shares (source: <https://www.marketscreener.com/quote/stock/NISUN-INTERNATIONAL-ENTER-32614343/company/>).

QMIS Financial Group is honored to have such a prominent and prestigious leader as its Founder and President. With the listing of QMIS TBS Capital Group Corp on Nasdaq in the pipeline, Tan Sri Dr. Chin will definitely lead the group to greater heights.
