- As proof of their first-year status, applicants will need to submit a digital copy (PDF or JPG/PNG) of their acceptance letter on the institutional letterhead.

### **How to Apply for the Scholarship by MANGAL, PLLC**

In order to apply for the scholarship, the applicants will need to submit an essay of 1000+ (not more than 1500) words in response to the question below:

*Is it economically efficient to have a system that requires attorneys to act as intermediaries between injury claimants and their insurers? First, explain the exact market role you believe injury attorneys to play in this relationship. Next, discuss the economic efficiency question above. If you believe it to be efficient, why and in what ways does it beat its alternatives? If not, why and what system do you propose in its stead?*

By submitting the essay to MANGAL, PLLC - [Clermont Personal Injury Lawyer](#), an applicant agrees that their essay may be featured in the Blog section of the law firm's website. The published essays may appear with minor changes in the original piece.

### **Instructions to Apply for the Scholarship**

- To submit the application, an applicant must email the completed essay and a digital copy of the acceptance letter from their college or law school, verifying their first-year status (details above), along with some brief information about themselves to [scholarship@lawbyyourside.com](mailto:scholarship@lawbyyourside.com).
- Applicants may optionally send their photograph and indicate whether or not they would be okay with the law firm publishing the same next to their essay if they win.
- The mail body must include: the applicant's full name, address, phone number, and the name of the current/planned college or school.
- The essay must be attached to the application email as either a DOCX or. PDF. Kindly adhere to MLA formatting guidelines, i.e., 12 pt. font, Times New Roman font style, double-spacing, etc. When submitting the essay, kindly cite any sources used.
- The subject line of the email must start with the applicant's name, followed by "Fall 2022 Scholarship." For example, if the applicant's name is Marcus Aurelius, the email subject line should read "Marcus Aurelius Fall 2022 Scholarship."

## General Guidelines

- Applicants must attach all the necessary documentation (mentioned above) to a single email, containing everything an applicant needs to provide.
- Applicants must check if all information is correct and proofread everything before sending the email.
- Any failure to follow the instructions above may disqualify the application.

The due date to apply for the scholarship is **July 31, 2022**. All completed applications must be sent to **[scholarship@lawbyyourside.com](mailto:scholarship@lawbyyourside.com)**.
