He then completed a fellowship in pediatric surgery at the Children's Hospital of Alabama at the University of Alabama in Birmingham, Alabama.

Holding a license to practice medicine in California, Missouri, and Alabama, the doctor is board-certified in pediatric surgery and general surgery by the American Board of Surgery (ABS). The ABS is an independent, non-profit organization located in Philadelphia, Pennsylvania, founded for the purpose of certifying surgeons who have met a defined standard of education, training, and knowledge.

After finishing his postdoctoral training in 2002, Dr. Keshen served on the faculty at the Washington University School of Medicine in St. Louis, Missouri, where he joined his wife, Dr. Roberta Sengelmann. He was an Assistant Professor of Pediatrics and Surgery and the Director of Pediatric Minimally Invasive Surgery at St. Louis Children's Hospital.

Maintaining fellowship status, he is a Fellow of the American College of Surgeons (FACS), and a Fellow of the American Academy of Pediatricians (FAAP).
