Most countries have to get the marriage certificate attested here, with the exception of those that have diplomatic ties with the UAE. The marriage certificate attestation in UAE can be done at the courthouse in the country you are coming from. If you are married, the attestation process will not take more than a couple of days to complete.

If you are marrying a local, you will be required to produce some documents to prove your relationship with that person. The whole process usually takes a long period of time, though. The document attestation process takes several months, sometimes years. You will have to go through a series of interviews and background checks. If you are married to a local, you can live and work here, but the only problems that you will face are those regarding the education of children.

It is a requirement from most schools and colleges to have the certificate attested by the UAE Embassy in your country. Everything else in the UAE is relatively easy and fast for newlyweds. The UAE government requires attestation for all documents issued outside the UAE. The attestation is done by the respective embassy of issuing country as per their norms.

Marriage certificate attestation in Dubai, UAE is necessary if you want to get married on certificates issued outside the country. Marriage certificate attestation in Dubai, UAE is done by the UAE Embassy and they will attest the marriage certificate before it is considered legal. The procedure of Marriage Certificate Attestation

Marriage in UAE is a bond made by the bride and the groom. It is a legal contract between two people. Marriage is not merely the bond of two people, but it is the bond of two families. The couple is supposed to be emotionally stable and mature enough to maintain their relationship. The complete process of attestation of Marriage certificates in UAE varies from case to case. The process may be different for a diplomat who is serving in a foreign country or for the expatriate who is staying in UAE for professional purposes. The process of attestation of a Marriage Certificate in the UAE differs when it is done by the UAE Embassy official in the home country of the Bride or the Groom. The expatriates may take the help of their embassy and the embassy will guide them through the process.

- The process of attestation of the marriage certificate is fairly simple.
- You may visit the Attestation Section of the Ministry of Foreign Affairs of the UAE.
- A legal marriage certificate issued by the religious court of UAE is required to get an attested marriage certificate.
- It has to be attested by the Ministry of Foreign Affairs of UAE.
- First is the Ministry of Foreign Affairs second is the Ministry of Justice and the third is Ministry of Interior.
- Ministry of Foreign Affairs process is simple, but some countries don't need it.
- Ministry of Justice attestation is done in Dubai.
- Ministry of Interior attestation is done in Abu Dhabi.

Purposes of having Marriage certificate attestation UAE

- A marriage certificate is necessary when individuals want to use it for legal purposes and want to use this certificate from abroad.
- In this case, the certificate must be attested to the specific authority in UAE and must be legalized by the Ministry of Foreign Affairs.
- If a document is not legalized and attested in the country where it was issued, then it will not carry any legal standing in other countries.
- Marriage Certificate Attestation in UAE is very essential as it gives the document the necessary legal weight.
- After attestation of the certificate, there is a tamper-proof seal applied to the certificate to ensure

that it is not altered in any way.

- Marriages in the UAE can be conducted in two ways.
- One through a government department and the other through an Islamic religious tribunal, but both need a Marriage Certificate to be obtained.
- It is issued by the Civil Status Department, which also requires the couple's attestation from the religious court.
- You can get it attested from a UAE Embassy/Consulate in your country or you can get it attested in UAE itself.
- The most authentic attestation services in UAE are provided by Al Bayan Legal services.

Why a marriage certificate is required:

- A marriage certificate is proof of marriage, registered by the marriage officer with his signature and seal.
- A marriage certificate shows that the couple is legally married and gives them the right to enjoy benefits and responsibilities like any other married couple.
- A marriage certificate is required when you want to get a job, when you want to apply for a passport.
- In accordance with the law of our country, a marriage certificate is necessary to establish a clear history of marriage, and to inherit the property without dispute.
- In addition, after the death of your parents, you need to have a marriage certificate to raise the inheritance issue.
