

“El Turco” Hilsaca triumphs in a Long Legal Escapade

El Turco Hilsaca AGM Desarrollos Secure Municipal Contracts, Become Target of Corruption, Gangs.



Cartagena, Bolivar Jun 28, 2022 ([Issuewire.com](https://www.issuewire.com)) - Alfonso “El Turco” Hilsaca, a global businessman, and developer philanthropist endured years of government corruption, legal prejudice and personal vendettas in a long legal saga. Mr. Hilsaca, known as 'El Turco' Hilsaca, is now triumphant and exonerated, as the legal case fell apart by admitting lies and legal irregularities.

In a plot to incriminate Turco Hilsaca, accomplices arrived at a well-known restaurant in the exclusive sector of Bocagrande and went to the table where the controversial businessman Alfonso del Cristo 'el Turco' Hilsaca was. The criminals held their victim at gunpoint and took his Rolex watch and other belongings. The controversial businessman Alfonso del Cristo Hilsaca Eljadue is being prosecuted in the Prosecutor's Office for the alleged contribution and financing of paramilitary groups. It was later

shown to be false.

It is denied that the robbery was to perpetuate a narrative in which El Turco Hilsaca is framed for murder-for-hire and financing gang activities. The evidence of the Attorney General's Office against what it described as a "criminal organization within the Barranquilla Judicial Services Center" even includes testimonies of a heated discussion between officials, one of them an alleged member and a fugitive from justice, for the alleged manipulation. of the assignment of dates and judges for the hearings of the Hilsaca case, as established in the [2015 ElHelrado article](#).

Sr. Alfonso Hilsaca Eljadue, his family, and corporation, AGM Desarrollos SAS, would become the [target of a deep a plot due to securing of Municipal projects](#). Upon securing the contracts, the organization and family of Hilsaca Eljadue, known as "El Turco", became the target of corruption, and a campaign to intimidate and besmirch the reputation of El Turco Hilsaca. international success in mining, construction and development. With his company, AGM Desarrollos SAS, he has secured long-term government projects in several Latin American countries, including Colombia, El Salvador, and Paraguay.

With the facts exposed, justice and truth would finally come. Looking back at the conditions, fact after fact uncovered makes it impossible to maintain the false conspiracy against Turco Hilsaca. Take, for example, in 2014, a file from an investigation against the prosecutor of the 'Turco' Hilsaca case for enrichment was discovered and exposed as highlighted in the 2014 article in [ElHelraldo](#).

Hilsaca Eljadue was arrested at the end of 2014 and was accused on that occasion by the national director of the Special Prosecutor's Office against Organized Crime, Álvaro Sarmiento, of the crimes of homicide and alleged financing of illegal gangs. This would then be exposed as part of a deep conspiracy and detailed campaign to smear and illegitimately 'fix' business crime, gang involvement and legal corruption on an innocent family and businessman.

In 2015, the Criminal Court of the Cartagena Circuit was ordered to dismiss this case ([ElHelrado](#)), later in 2015, the fourth criminal judge of the circuit, Gloria Giraldo Ruiz, confirmed the decision that revoked the preventive detention measure of Alfonso del Cristo Hilsaca Eljadue. The decision was an apparent catalyst for the vandalism and destruction of a large portion of the Hilsaca Hacienda. The Hilsaca farm was the object of an arson attack and the burning of a farm, in the municipality of Arjona.

Unsavory players in government and corporate positions conspired to bring down El Turco Hilsaca, in an effort to secure government contracts from other corrupt players. The man, nor the company would not back down. Mr. Hilsaca did not achieve success by being bullied or maneuvered.

The citizens of Colombia are victorious with the justice associated with the "Turco Hilsaca", AGM Desarrollos and the Hilsaca Family. Government contracts linked to AGM Desarrollos are being fulfilled, on time, ahead of schedule and within budget, without the cost and the disappearance of corruption.
