In the past, he held staff positions at the University of Florida College of Medicine, Nova Southeastern University College of Osteopathic Medicine, Northwest Medical Center, Coral Springs Medical Center, and Mount Sinai Medical Center. He is also the past President of the American Osteopathic College of Dermatology (AOCD), President of the Foundation for Osteopathic Dermatology (FOD), and past President of the Broward County Dermatologic Society.
