If you’re unable to perform jobs for 12 consecutive months or have a terminal condition, you may be eligible for SSDI or SSI. If you’ve taken off from work on your physician’s advice, you are entitled to temporary disability, which is approx. 2/3 of your pay. Mr. Chalk is expert in managing both SSDI and SSI cases through the Office of Disability and Adjudication Review in Northern California. SSDI cases require the claimant to pay for the SSA system, if the claimant didn’t pay for requisite quarters, then they may qualify for SSI. If you are a member of a police officer, firefighter, or correctional officer and experiencing a work injury, you may be eligible for industrial disability retirement.
