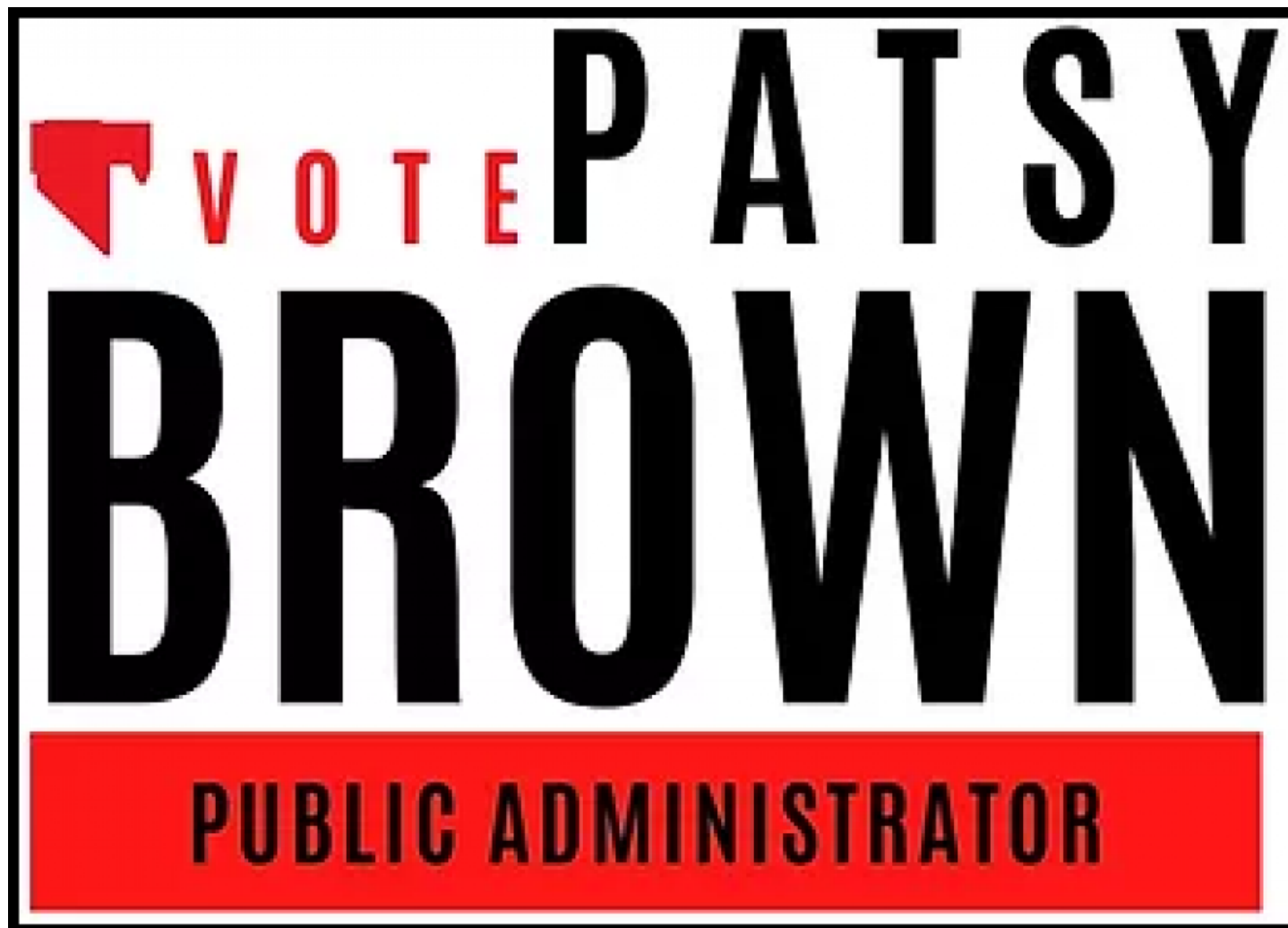


Patsy Brown, Candidate for Clark County Office endorsed by Fmr. Alternative Municipal Judge and Deputy District Attorney

From the early 1980's through 1986, he was a partner in Brown, Wells, Beller, Kravitz. In 1986, he ventured off as a sole practitioner, which he continues to do today. Practicing with an emphasis in business and general litigation, Neil has represented a diverse range of companies and individuals throughout the years. He has strived to meet all of his clients' needs for legal representation. He has also worked as outside counsel for the board of realtors and done zoning work as an attorney. Neil has also been a Deputy District Attorney and an Alternative Municipal Judge.

Neil has been on the fee dispute committee of the State Bar of Nevada in excess of 10 years, and on June 23 , 2021, the Board of Governors approved his appointment to the Southern Nevada Disciplinary Board through July 1, 2024.
