There are a few key points below that you should be aware of:

#### A Case-Related Interview

The criminal defense lawyer should make every attempt to find out as much information as they can about the case before speaking with the client in person. By asking pertinent questions, he or she can learn more by learning about prospective defenses, the case's advantages and disadvantages, and other things. This calls for probing, in-depth inquiries to be asked of the defendant.

## The Case's Investigation

He or she must conduct more studies into the situation to identify any potential opportunities to exonerate the perpetrator, in addition to asking the criminal defendant incisive questions about the case, claims <u>Aly Sosa</u>. This typically involves questioning the police about the techniques they used to solve the case. Gathering information and speaking with witnesses who can shed light on the situation may also be included. The objective is to use all of this information to create a strong defense. If an expert

witness is asked to testify, the criminal defense lawyer may interrogate the witness regarding the potential testimony and supporting evidence.

A criminal defense lawyer gets the chance to evaluate the prosecution's case before the case is presented to the jury. In doing so, he or she is better equipped to see any holes in the prosecution's case against the defendant and search for evidence that might disprove it, for as by calling a third-party lab or expert witness to testify.

## **Evidence Analysis**

Before assessing the evidence presented against a criminal client, a criminal defense lawyer must carefully study the case's facts and theories. He or she could have requested that the evidence be reviewed by a third party. Additionally, he or she might evaluate the evidence to determine if any legal theories provide credence to the exoneration of his or her client.

## Maintaining Communication with the Client

To inform their client of any developments in the case and to keep them informed, a criminal defense lawyer must remain in contact with them. According to Aly Sosa, the lawyer must ensure that client communications are kept confidential. For the client to understand the potential consequences, the attorney must also see to it that the client is informed about the situation.

## Selecting a jury

Criminal defense counsel assists in jury selection. He or she may try to have them removed for cause if they show signs of prejudice against the defendant or even if they are merely unhappy about a potential juror.

# The Case's Assignment

The defendant has the option of directly contacting a criminal defense lawyer or having one appointed to their case by the court. Criminal defense lawyers who serve as public defenders are well compensated by the public defender's office. They are assigned cases by local, state, or federal courts. Private businesses hire more criminal defense lawyers. Some criminal defense lawyers run their independent legal firms.

Public defenders sometimes make less money than private attorneys and handle more cases as a result of the referral process and the fact that they get payment from parties other than defendants. Sometimes a court will choose a private counsel to represent them in a particular case.

# Plea Negotiation

Additional responsibilities of a criminal defense lawyer include negotiating prospective plea bargains and updating the prosecutor on the status of the case. The defendant may be able to negotiate a good deal that results in fewer accusations or possible fines with the aid of a criminal defense attorney.

#### Participation in trials

According to <u>Aly Sosa</u>, a criminal defense attorney who defends a client in court. He or she conducts witness interviews, cross-examinations of state witnesses, and attempts to present evidence to persuade the jury that the prosecution hasn't done enough to establish its case.

# Sentencing

The criminal defendant may be represented by a criminal defense counsel during the sentencing phase if the criminal defendant is sentenced for the offense either because he or she accepted a plea agreement or was found guilty by the court or jury. He or she might discuss points that might convince the judge or jury to reduce the defendant's sentence as well as provide possible alternatives to incarceration.
