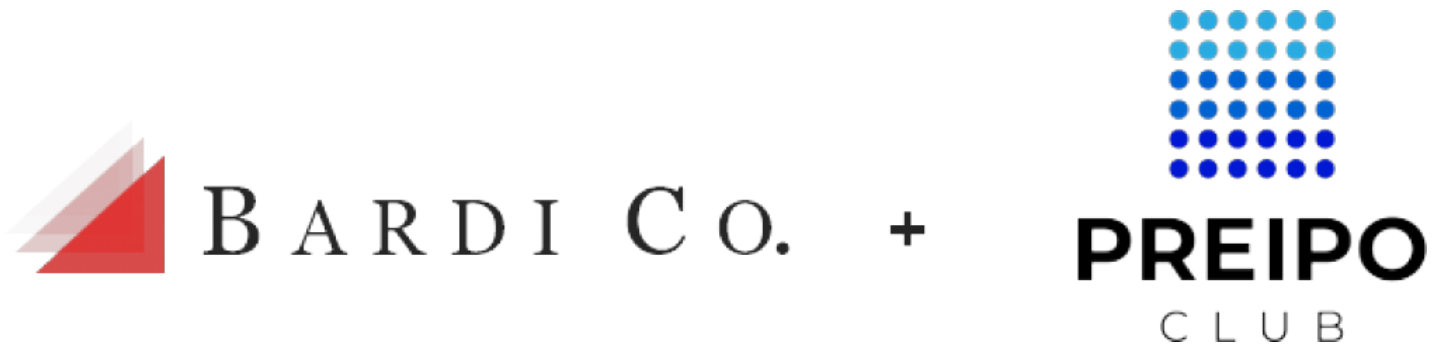


Bardi Co. and PRE IPO CLUB Launch a Joint Venture for Private Markets
