New Delhi, Delhi Feb 11, 2023 (IssueWire.com) - Now visiting India for a short time period is easier with the new Indian e-Visa program. It was launched in 2014, and since then foreigners would not need to apply for a regular visa when they are visiting the country for a short time. Now it is available for the citizens of Malaysia and the **INDIAN VISA FOR MALAYSIAN CITIZENS** would not require a physical visit to the Indian embassy to attain. As a member of the launch program of the Indian e-Visa, Norwegian citizens can use the Indian e-Visa while visiting the country by seaports and air. They can get an Indian e-Visa for tourism, business, or medical purposes.

The Indian tourist e-Visa is valid for 1 month, 1 year, and 5 years and the business visa will be available for 12 months. New Zealand was another launch member of this Indian e-Visa program, so New Zealand citizens also get similar benefits. The application process for Indian e-Visa is kept easy and very minimal. This can be completed in just a mere 5 minutes and doesn't require a physical visit, not even at the time of the visa delivery. The citizens of Switzerland also adhere to similar benefits.
