

Travel to the Picturesque Land of Culture and Wonders Hassle-free with the Indian eVisa



What is India eVisa (or Indian Visa Online)

New Delhi, Delhi Feb 10, 2023 ([Issuewire.com](https://www.issuewire.com)) - In the 2023 tourism policy drafted by the central government of India, there are talks of a paradigm shift in the tourism sector of the country. According to reports, about 69 lakh foreign tourists were estimated to have visited India in 2022, which indicated a four-fold increase in the arrival of tourists in the post-covid scenario. Previously, this would have meant that tourists intending to visit the country would have to stand in long queues and wait for months to get their Visas approved. But not anymore. Citizens of different nationalities can now apply for the Indian eVisa and enjoy their visits to the country hassle-free.

Being a launch member of the India eVisa program, Andorran citizens can enjoy fast entry into the country by applying for the **Indian Visa for Andorra Citizens** online, which allows Andorran citizens to stay in the country for short terms of 30, 90, and 180 days per visit depending on the purpose of visit. Azerbaijani Citizens can also enjoy similar benefits of the eVisa by applying for the **Indian Visa for Azerbaijan Citizens** by logging into <https://www.indiavisa-online.org/india-visa-eligibility/india-visa-for-azerbaijani-citizens/>. It allows Azerbaijani citizens to visit India for tourism, medical and business purposes.

If nationals from Barbados have a valid email id, and a Credit / Debit card in 1 of the 133 currencies or Paypal, they can now apply for **Indian Visa for Barbados Citizens** and receive their eVisa to India via email. After applying for the **Indian Visa for Belarus Citizens**, the waiting time for receiving the eVisa is 3-4 business days at the earliest, though in certain cases citizens can attempt a rush processing. It is advisable to apply for the eVisa at least 4 days before the day of travel.
