As Carpal Tunnel Syndrome improved, he started educating him on the power of the body and nervous system which gave Dr. Bodine the motivation to become a chiropractor and help others.

Before coming to Wise Chiropractic, he worked for some of the most successful chiropractic clinics in the country. He also traveled the country, coaching and teaching thousands of chiropractors around the country over a ten-year span.
