
## **Enjoy a Reposeful Traveling Experience to India with the Perks Offered by the Indian e-Visa**

The **Indian Business Visa for US citizens** is an official document that allows citizens of the US to enter and travel within India for commercial or business purposes. Similar rules apply to British citizens traveling to India for commercial or business purposes. The **Indian Business Visa for UK citizens is** valid for a total of 365 days from the date of issue and is a multiple-entry Visa that allows them to stay in the country for a total of 180 days.
