India eVisa Application

Launched in 2014, this e-Visa can be applied to and collected online. The travelers would not even be required to physically visit the Indian embassy and the eVisa will be sent directly to the applicants' email addresses. If you are a US citizen who wants to come to visit India, then visiting India for a short stay is possible with the Indian e-Visa and the application process can be completed in just 2 minutes. The application process requires only minimal documents where personal details, employment details, and passport details are required to be submitted. In addition to that, US citizens would require submitting a face photograph with a clear background. The **Indian Visa Application Online** can be acquired for mainly three purposes, which are tourism, business, and medical or transit visit purposes. The entire process can be completed in less than 5 minutes and requires very minimal information to get approved. The process of getting the India e-Visa application approved is usually done in three steps. The applicants need to submit their personal details such as family name, date of birth, place of birth, country of citizenship, email address, etc. The next step is about reviewing and confirming the payment and the last step is to receive the approved visa. Besides the most popular Indian Tourist e-Visa, as mentioned above, there are also Indian Business e-Visa and Indian Medical e-Visa. The Business e-Visa for India allows travelers to stay in the country for up to 180 days and this multiple-entry **Indian Business Visa** is valid for 1 year.
