India eVisa Application

New Delhi, Delhi Apr 27, 2023 ([Issuewire.com](https://www.issuewire.com)) - Since ancient times, India has been a hub that has attracted travelers from all over the world with its mesmerizing scenic beauty, vast medical legacy, and commercial prospects. With time as modes of transport developed and transport became faster and easier, the number of tourists traveling to the country has been also multiplied. The post-pandemic period recorded one of the greatest influxes of tourists to the country for various purposes. A major impetus to the tourism industry in the country was the introduction of the Indian e-Visa which allowed citizens of 180 countries to travel to the country without acquiring a physical stamp on their passport.

The Indian eVisa is of three types: Tourist e-Visa, Business e-Visa, and Medical e-Visa. If a foreign citizen is traveling to accompany a patient who will be getting medical treatment in India, they should apply for the **Indian Medical Attendant Visa** online, details of which are available at <https://www.india-visa-online.org/types/india-medical-attendant-visa/>. It allows them to remain in the country for 60 days from the date of entry.

The **Tourist Visa for India**, on the other hand, allows potential visitors to stay up to 180 days in the country at one time. It is eligible for those who are coming to the country for a vacation or to visit their loved ones. Travelers visiting the country to take a course or program that will grant them no degree or diploma certificate or to be a part of a volunteer program can also apply for the **India Tourist Visa**. In case a foreign national is visiting the country for business or commercial purposes, they would have to apply for the **Indian Business Visa**, which can be done through <https://www.india-visa-online.org/types/india-business-visa/>. This multiple-entry Visa is Valid for one year and allows the applicant to stay in the country for 180 days at one time. While applying for the **Business Visa for India**, it is important to keep certain tips in mind such as keeping all necessary documents in order and staying up-to-date on vaccinations.
