However, many users find some of these products uncomfortable and inconvenient. Nicoccino has addressed this concern by launching tobacco-free nicotine strips that are only 0.07-millimetre-thin, easy to use, and releases nicotine within seconds.

The strips can be used anywhere and at any time, even in places with smoking restrictions like airplanes, sports arenas, restaurants, and bars. The compact packaging is designed to fit into all kinds of pockets and bags, making it easy to use and discreet.

The nicotine strips are manufactured in Sweden and are currently available exclusively through Nicoccino's web shop. However, the company plans to expand its distribution network in 2023 through

various distributors. Nicoccino has invested significantly in machinery that will enable it to produce more products and customize them according to its customers' needs.

According to the company's CEO, Michel Bracké, Nicoccino's nicotine strips offer a superior nicotine solution that addresses the concerns of smokers without compromising their health or the environment. The product has the potential to become the nicotine solution of the future.

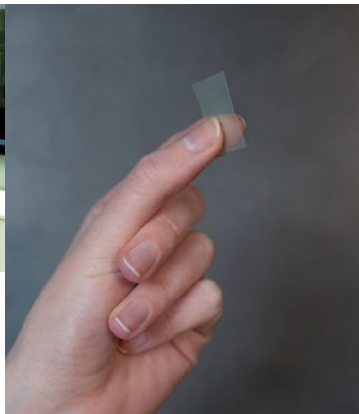
