
## A Visit to India Becomes a Piece of Cake with the Indian e-Visa

Effective in September 2019, travelers from the United Kingdom can now avail of a **5 year Indian Visa for UK citizens** which is a multiple-entry Visa that allows them to enter the country many times during a span of 5 years. Similar benefits can be enjoyed by American tourists by applying for the **5 year Indian Visa for US citizens** at <a href="https://www.india-visa-online.org/5-year-tourist-visa-us-citizens/">https://www.india-visa-online.org/5-year-tourist-visa-us-citizens/</a>. It allows visitors a maximum of 180 days of continuous stay during each visit within the span of 5 years and the validity of the e-Visa is accountable from the date of issue rather than the date of the applicant's entry into the country.

However, visitors from the US traveling to India for business purposes would have to apply for the **Indian Business Visa for US Citizens**. In order to apply for the Business e-Visa for India, US citizens would require a US passport valid for at least 6 months from the date of departure from India and a scan of the Passport Information page, a digital portrait photo of the applicant, and a copy of their business card.
