
## **Enjoy the Best of Everything New Zealand has to offer with the New Zealand Electronic Travel Authority (NZeTA)**



**Auckland, New Zealand Jun 6, 2023 (Issuewire.com)** - Over the years, the island country in the southwestern Pacific Ocean, New Zealand, has become the abode of foreign visitors, offering them a diverse and unique range of scenic and cultural beauties, and outdoor activities. In order to further increase the ease of travel for foreign visitors, the New Zealand Electronic Travel Authority (NZeTA) was introduced in 2019, allowing them to visit the country for short trips or for business and transit purposes without going through the hassle of obtaining a paper Visa. Visitors from all European Union nations along with 36 other countries can now enjoy the benefits of the NZeTA.

A launch member of the NZeTA program, visitors from Romania can enjoy easy entry into the country by air and cruise ship by applying for the **New Zealand Visa for Romanian Citizens** online at <a href="https://www.new-zealand-visa.org/new-zealand-eta-eligibility-for-romanian-citizens/">https://www.new-zealand-visa.org/new-zealand-eta-eligibility-for-romanian-citizens/</a>. However, the applicant must be at least 18 years of age or they will require the approval of a parent/guardian.

Passport holders of San Marino can apply for the **New Zealand Visa for San Marino Citizens** at <a href="https://www.new-zealand-visa.org/new-zealand-eta-eligibility-for-san-marino-citizens/">https://www.new-zealand-visa.org/new-zealand-eta-eligibility-for-san-marino-citizens/</a> by filling out the online application form. This Visa waiver program allows visitors to travel to the country for a period of three months or less via flight as well as a cruise ship.

To apply for the **New Zealand Visa for Slovak Citizens**, applicants would require a passport valid for at least 3 months after the date of arrival to the country, a Credit or debit card to pay for the NZeTA and the traveler levy, and a portrait photo to be uploaded digitally. When applied online, the **New Zealand Visa for Seychellois Citizens** is usually approved within 3 days. Potential travelers are however advised to apply prior 4-7 business days to avoid last-minute rush, delay, and disappointment. Visitors from Saudi Arabia can enjoy similar benefits by applying for the **New Zealand Visa for Saudi Arabian Citizens** online at

https://www.new-zealand-visa.org/new-zealand-eta-eligibility-for-saudi-arabian-citizens/. The NZeTA is a multiple entry visa that remains valid for up to 2 years or the expiration of the passport.
