
## **Enjoy the Perks of the Indian e-Visa and go Hassle-free During Your Next Visit to the Country**

With the country's increasing impact and influence in international society, the influx of tourists to the country has peaked more than ever in the last decade, not to mention the massive role played by the advent of the Indian e-Visa. Visitors from Visa waiver countries can now enter India without the added hassle of getting their paper Visas approved by the embassy or consulate for short stays, which might otherwise take a significant length of time.

The **Indian Visa for Norwegian citizens** allows them entry into the country for tourism, clinical visits, conferences, yoga courses, workshops, deals and exchanges, humanitarian efforts, and business ventures. The **Indian Visa for New Zealand citizens** can be applied for online by filling out the online application form available at

https://www.india-visa-online.org/indian-e-visa-eligibility/new-zealand-citizens and the applicant can pay for it in New Zealand Dollar or any of the 135 currencies approved for the Indian e-Visa using a valid Debit/Credit card or through Paypal.

Swiss citizens can similarly apply for the Indian e-Visa and if the application process is seamless and error-free, the **Indian Visa for Swiss citizens** is sent to the valid email provided by the applicant in 3-4 business days. However, in some cases, depending on the rush and the correctness of the data, the process can take as long as 7 days. To apply for the **Indian Visa for US citizens**, the applicant would require a passport valid for at least 6 months from their date of departure from India, a return ticket to the US, and a separate individual passport even in case of minors or children. Bulgarian visitors can enjoy the benefits of the Indian e-Visa by applying for the **Indian Visa for Bulgarian citizens** online at

However, there are certain limitations such as Bulgarian citizens cannot come to India for journalism, filmmaking, long-term paid work, or for pursuing a university degree with the e-Visa.
