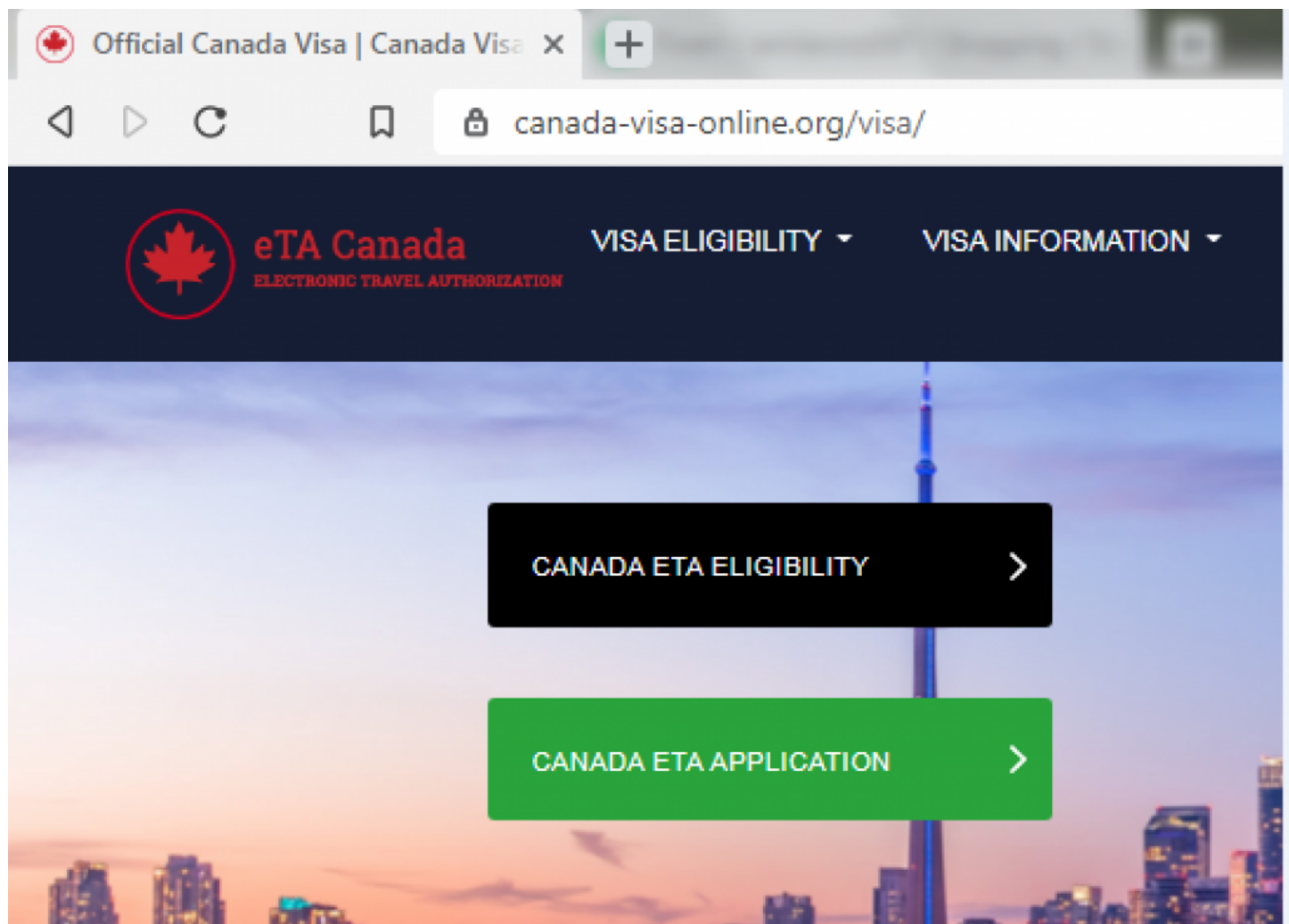


Enjoy Your Next Trip to Canada with the Easiest and Fastest Entry Using Canadian e-Visa

But getting a traditional visa would require travelers to physically visit the Canadian embassy and stand in a long line. This can be solved by using the newest, most efficient Canadian e-Visa. If the purpose is tourism, travelers can get **CANADA VISA FOR TOURISTS** online and the Canadian government fee ranges between \$7 to \$100 for an eTA. Citizens of Chile can take this advantage and guarantee easy entry to the country by using this Canadian Electronic Travel Authorization for a short stay. The **CANADA VISA FOR CHILE CITIZENS** is valid for arrival by air only and is applicable for short tourist, business, and transit visits. The **CANADA VISA APPLICATION PROCESS** is kept minimal and can be done completely online. The entire application process can also be completed in just a few minutes. The requirements are also kept very simple. For an approved Canadian eTA, there are just three requirements, a valid passport, a valid email address, and a valid payment method. This payment can be done by using a credit card, or a

debit card (Visa, Mastercard, UnionPay), or through PayPal. The Canadian eTA will be directly linked with the passport of the visitor and will be sent directly to their email addresses. As it typically takes 10-30 minutes for the application process to be completed, if the documents are ready it can be done in under 10 minutes. The **CANADA VISA FOR BELGIAN CITIZENS** is valid for 5 years from the date. The departure of visitors must be within 90 days of arrival. If travelers wish to stay for a longer time, they must apply for other relevant visa options. Know the details at <https://www.canada-visa-online.org/canada-visa-eligibility/belgian-citizens>. Similarly, the **CANADA VISA FOR SPANISH CITIZENS** is also valid for 5 years. To obtain the Canadian eTA, the applicant must be over 18 years or require a legal guardian or parent at the time of the application.
