

Secure Your Fast Entry in India for a Short Stay with the Indian eVisa



What is India eVisa (or Indian Visa Online)

New Delhi, Delhi Jun 20, 2023 ([Issuewire.com](https://www.issuewire.com)) - The Government of India has taken a new initiative where foreigners from eligible countries can travel to India by using the Indian e-Visa without any hassle. Now Mexican passport holders, as the country is one of the 169 countries eligible for the eVisa, can enjoy their fast entry to the country, without ever visiting the Indian embassy. The **INDIAN VISA FOR MEXICAN CITIZENS** can be applied online and upon approval, it will be directly sent to the applicants' email addresses. Visit <https://www.indian-visa-online.com/india-online-visa-for-mexican-nationals/> to know the details. Similarly, for New Zealand citizens, the application can be done in just a mere 5 minutes. The required documents for the **INDIAN VISA FOR NEW ZEALAND CITIZENS** include a valid passport that must have a validity of at least 6 months from the date of arrival in India. In addition to that, another requirement is valid bank account information (credit/debit card, or a PayPal account)

The **INDIAN VISA FOR NORWEGIAN CITIZENS** requires a recent photograph of the applicant facing forward along with a scanned copy of the passport. The processing time of the Indian e-Visa is generally two to four days. However, it is recommended to apply for the visa at least five days before the departure date for unforeseen delays. Depending on the purpose, here are the categories an Indian e-Visa can be applied for; Indian e-Tourist Visa, Indian e-Business Visa, Indian e-Medical Visa, Indian e-Medical Attendant Visa, and Indian e-Conference Visa. Similarly, the **INDIAN VISA FOR PERU CITIZENS** is valid for a total of 120 days. The Indian e-Tourist Visa has a validity of 30 days, one year, or five years, whereas the Indian e-Business Visa is valid for one year. The Indian e-Medical Attendant Visa and e-Medical Visa, both are valid for 60 days and the Indian e-Conference Visa is valid for 30 days.
