# India eVisa Application

**New Delhi, Delhi Jun 30, 2023 (Issuewire.com)** - Obtaining travel visas to any country requires travelers to go to the nearest embassy and submit a physical application. The Indian government has started a program called Indian eTA which is an Electronic Travel Authorization that allows foreign nationals to submit an online application for an Indian eVisa. The **INDIAN VISA FOR GREEK CITIZENS** is valid at designated airports and seaports only. Adults can directly apply for the visa online and people who are under the age of 18 can apply under the authority of a parent or a legal guardian. The application for the **INDIAN VISA FOR CROATIAN CITIZENS** has been kept really simple and easy and can be completed in just a few minutes. There are three types of Indian online visas available, such as; tourist eVisa, business eVisa, and medical eVisa. The Tourist e-Visa for India is available for 1 month, 1 year, or 5 years. As Japan was a launch member of this Indian eTA program, the **INDIAN VISA FOR JAPANESE CITIZENS** is also available, granting travelers from Japan the same advantages. The Indian Visa from Japan can be procured online and applicants can pay using Japanese Yen or any of the 135 currencies including Debit/Credit/Paypal. The Government of India started this program in 2014, and since then the applications for obtaining an Indian eTA can be sent and received online, without paying a physical visit to the nearest Indian embassy. The **INDIAN VISA FOR LATVIAN CITIZENS** gives them a 90-day continuous and uninterrupted entry into India. Obtaining the **INDIAN VISA FOR MALAYSIAN CITIZENS** is valid for 5 years and a multiple-entry visa. The only requirements are a valid passport, a valid email address where the visa will be directly sent, and a valid payment method; a credit/debit card, or a PayPal account.
