

Since the Advent of the NZeTA, Traveling to New Zealand Has Never Been Easier



Auckland, New Zealand Jun 25, 2023 ([Issuewire.com](https://www.issuewire.com)) - New Zealand's biggest export earner before the pandemic, the tourism industry of the country has been rekindling with an added impetus after lifting the lockdown restrictions. With the added influx of foreign tourists, the government of New Zealand introduced the New Zealand Electronic Travel Authority (NZeTA), paving the way for better international relations through ease of travel to the country. The NZeTA allows citizens from Visa Waiver countries to visit New Zealand without the hassle of waiting long hours and making trips to the Embassy to get their paper Visas approved for short trips.

The NZeTA, a mandatory requirement for travelers from Bahrain, allows them to visit the country for 90 days. To apply for the **New Zealand Visa for Bahrain Citizens**, applicants must ensure that their passport is valid for at least three months from their date of departure from New Zealand. Potential visitors from Taiwan can obtain the **New Zealand Visa for Taiwan Citizens** online by filling out the online application form that takes a matter of minutes. However, the applicant must be in the pink of their health and must not have a criminal history. Foreign travelers applying for the **New Zealand Visa for Finland Citizens** would require a valid credit or debit card or PayPal account to pay the NZeTA fee and tourist levy. Once approved, the eTA is sent to the valid email address provided in the application form. In case a data input is wrong, they will have to apply for another NZeTA. The online **New Zealand Visa for Lithuania Citizens** can be applied for at <https://www.new-zealand-visa.co.nz/new-zealand-eta-eligibility-for-lithuanian-citizens> and it remains valid for up to 2 years during which the applicant can visit the country multiple times for up to 90 days at a stretch. For longer stays in the country, they must apply for a relevant Visa suited to their requirement and circumstances.

Being a launch member of the New Zealand eTA program, potential visitors above the age of 18 can apply for a **New Zealand Visa from USA** online at <https://www.new-zealand-visa.org/online-new-zealand-visa-from-united-states/>. They are often advised to apply for the NZeTA 4-7 business days before their date of departure to avoid last minute rush. More relevant information can be found on the website.
