Update from UN Santa Fe about Pharmaceutical Genocide Prosecution in the Hague Courts

South Holland, Netherlands Jun 5, 2023 (<u>Issuewire.com</u>) - As Founder of the newest branch of the United Nations in Santa Fe, New Mexico, and having been recognized as such by heads of state, starting with the Royal Family of Spain more than 3 years ago, plus numerous United Nations Ambassadors, I am baffled by the slowness the 2 Hague courts in continuing the prosecution of 16 pharmaceutical genocidists, whose indictments were accepted by the Prosecutor of the International Criminal Court, Karim Khan, a Brit born Pakistani, the indictments given the number OTP CR 473 021.

Very few articles on this subject have been published in the USA Media, only about 3, in California, Kentucky, and Minnesota, the most definitive of which was by a physician with two specialties of practice, who out of fear for what he was writing about, was compelled to use a pseudonym, Dr. Justus R. Hope, M.D. That can be read by searching these terms: <Gates Fauci Genocide Desert Review> and was published December 20, 2021, in Brawley, California. Take 20 minutes and read it, please.

Because the victims were the people of the United Kingdom, not named among those indicted were the pharmaceutical genocide profiteers in India (like Cyrus and Adar Poonawalla and their Serum International chemjab corporation) and none of the pharmaceutical genocide profiteers in China with Sinovac: Yin Weidon, Lo Yuk Lam, Kenneth Lee, Mei Meng, Fu Shan, and others), none of the Russian Executives in Sputnik 5 (Gamaleya Research Institute of Epidemiology and Microbiology) which contained:

- <u>Tris(hydroxymethyl)aminomethane</u> (buffer)
- Sodium chloride (salt)
- Sucrose (sugar)
- Magnesium chloride hexahydrate
- Disodium EDTA dihydrate (a chelation ligand; sequestrant)
- Polysorbate 80
- Ethanol 95%

and none of the Japanese genocidal chromosomal implosion chem jab corporations, including GeneDesign, acquired by Ajinomoto Co. in 2017, but now will be under the control of its small-and large-molecule API producer, Ajinomoto Bio-Pharma Services. The deal comes as GeneDesign has completed a 2,000-square-meter facility that allows it to expand its synthesis and supply of the DNA and RNA molecules up to 10 kg.

Ajinomoto, the world's largest manufacturer of Asparame/Methanol/Formaldehyde as well as Monosodium Glutamate, two deadly neurotoxic exitotoxic carcinogenic abortifacients, had one thing in common with Pfizer: both Chairman of the Boards for many years were Veterinarians, Pfizer's still in charge, this Hague International Criminal Court indicted genocidist.

Al Bourla in May of 2022 told his Board of Directors and told Klaus Schwab, also indicted for genocide by the ICC, at a conference in Davos Schweiz, that he had a dream, to give the 45 poorest nations of the world the genocidal chem jab products of Pfizer at cost.

So, I sent the first two pages of the ICC Genocide indictments to the 80 poorest nations to the UN Ambassadors thereof, and asked them to forward it to the Justice and Health Ministers of those nations,

and by November of 2022, at the STAT Conference in Boston, a research and conference branch of the Boston Globe under questioning by Matthew Herper:[Asked about Pfizer's efforts to address global health inequities by making the Covid-19 vaccine available globally, Bourla expressed regret that 1 billion doses — sold at cost and shipped to low-income countries — went unused and had to be destroyed.]

"Very few of these 1 billion doses were used," said Bourla. "Another dimension of health inequities is infrastructure. African countries that were very vocal in the beginning about wanting vaccines, when they were offered the vaccines completely free, at their door, they couldn't absorb them."

Asked if Pfizer had a responsibility to ensure the Covid vaccine got into the arms of people living in low-income countries, Bourla said the issue was "everyone's concern," but he also pointed more specifically to the World Health Organization. "They had to prepare the ground in these countries, so that when vaccines became available, they could be used," he said.]

We must also at this point remind the reader that the Ethiopian Director of the World Health organization, Tedros Adhanom Ghebreyesus, was also indicted for genocide in the same Hague indictment.

[From Wikipedia: In May 2013, controversy intensified over the under-construction Hidase Dam in the Benishangul-Gumuz near Sudan as Ethiopia began diverting the Blue Nile for the dam's construction. At that time, the dam was more than 22 percent complete and expected to produce 6,000 megawatts, making it Africa's largest hydroelectric power plant. The dam was expected to have a reservoir of around 70 billion cubic meters, which was scheduled to start filling in 2014. Egypt, Ethiopia and Sudan established an International Panel of Experts to review and assess the study reports on the dam. The panel consisted of 10 members; 6 from the three countries and 4 international in the fields of water resources and hydrologic modelling, dam engineering, socioeconomic, and environmental. The panel held its fourth meeting in Addis Ababa in November 2012. It reviewed documents about the environmental impact of the dam and visited the dam site. The panel submitted its preliminary report to the respective governments at the end of May 2013. Although the full report has not been made public, and will not be until it is reviewed by the governments, Egypt and Ethiopia both released details. The Ethiopian government stated that, according to the report, the dam meets international standards and will be beneficial to Egypt, Sudan and Ethiopia. According to the Egyptian government, the report found that the dimensions and size of the dam should be changed.

On 3 June 2013, while discussing the International Panel of Experts report with President Mohammad Morsi, Egyptian political leaders suggested methods to destroy the dam, including support for antigovernment rebels. The discussion was televised live without those present at meeting aware. Ethiopia requested that the Egyptian Ambassador explain the meeting. Morsi's top aide apologized for the "unintended embarrassment" and his cabinet released a statement promoting "good neighborliness, mutual respect and the pursuit of joint interests without either party harming the other." Morsi reportedly believes that is better to engage Ethiopia rather than attempt to force them. However, on 10 June 2013, he said that "all options are open" because "Egypt's water security cannot be violated at all," clarifying that he was "not calling for war," but that he would not allow Egypt's water supply to be endangered. Tedros said the dam will be used exclusively for power generation and is being constructed in a way that takes Egypt's water security concerns into account. On 18 June, Tedros and Egyptian Foreign Minister Mohamed Kamel Amr issued a joint statement reiterating "their commitment to strengthen their bilateral relations and coordinate their efforts to reach an understanding regarding all outstanding issues between both countries in a manner of trust and openness building on the positive

developments of their relations." Both agreed to review the report of the International Panel of Experts and implement their recommendations, working to defuse the tensions and ease the crisis.]
