But visiting the Indian embassy and applying for the visa would take months for the Visa to finally arrive which can cause delay in traveling. This is why, the Indian Government to spare the discomfort has started the Indian e-Visa program which will allow travelers to get the visa online. The **Indian Visa from Finland** can be applied online, from anywhere and the application process hardly needs five minutes to be completed. As Hungary was a launch member of this program in 2014, it allows Hungarian citizens to have the same benefits. There are different types of **Indian Visa from Hungary**, depending on the purpose of the visit. For tourism, Indian Tourist e-Visa, and for business, there is Indian Business e-Visa. Hungarian travelers can enter India with a multiple-entry eTourist visa and stay there continuously for up to 90 days. The business eVisa is a double-entry visa that can be used to stay in the country for 180 days. Know more at: <https://www.india-visa-online.org/indian-visa-from-hungary/>. There is also an Indian medical e-visa that is available and requires an authorization letter from the receiving hospital for approval. The **Indian Visa from Kenya** has a validity of 60 days in one go for medical purposes. The triple-entry Medical visa is valid for 120 days after the date of issuance. Visitors can leave India by 4 different modes of travel, yet there are only two valid travel modes for entering the country. The **Indian Visa Airports and Seaports are allowed** as per the rule of immigration. The valid 29 Airports are Ahmedabad, Amritsar, Bagdogra, Bengaluru, Bhubaneswar, Calicut, etc. and 5 seaports are Chennai, Cochin, Goa, Mangalore, and Mumbai. The **Indian Visa from Laos** and its successful approval require three primary things, a valid passport with a minimum remaining validity of six (6) months, a working email address for electronic delivery of the e-visa, and a legitimate credit or debit card to pay the processing cost for visas.
