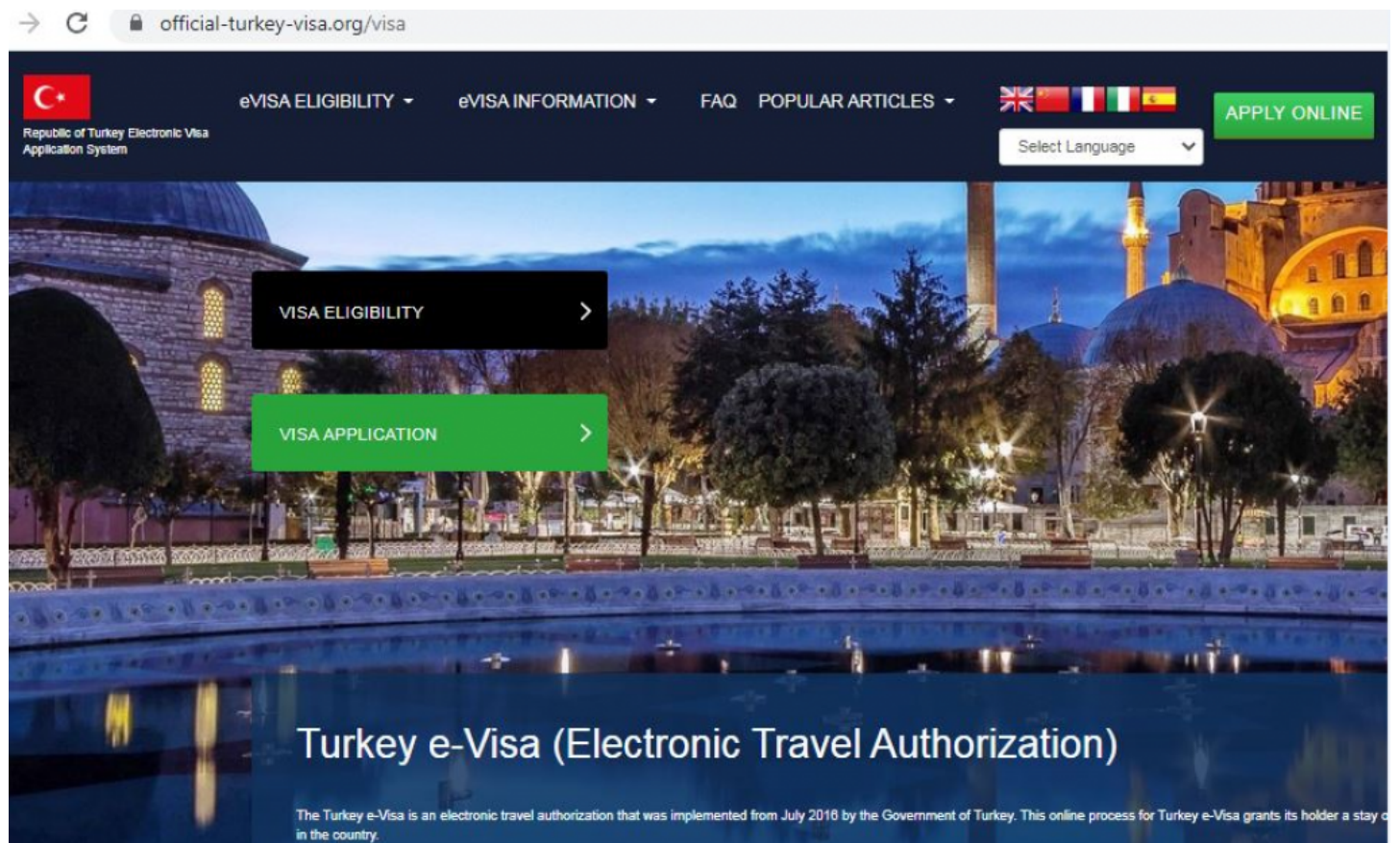


Visit Turkey Most Conveniently with Turkey eVisa



Istanbul, Turkey Jun 25, 2023 ([Issuewire.com](https://www.issuewire.com)) - Visiting Turkey would require a visa for foreign nationals which can be obtained in two forms, one is the traditional Turkey visa, and the other one is the Turkey eTA. The Turkey eTA is an electronic travel authorization that was issued and implemented by the Government of Turkey in 2016. The holder of a Turkey eTA can stay in the country for up to 3 months. The Turkey eTA is available for citizens from eligible countries who can visit the country only for three purposes, which are; Tourism and sightseeing, Transit or layover, and Business or trading. With a simple and hassle-free **Turkey Visa Application**, foreign nationals can apply for the visa and complete the process in just a few minutes. In just 24 hours, the applicants can get the visa directly sent to their given email addresses. However, the government of Turkey recommends submitting the application at least 3 days before the visit to the country. This **Turkey Visa for Omani Citizens** is a multiple-entry visa that will let Omani citizens stay in Turkey for up to 90 days. Travelers from Oman must enter Turkey for the first time within 180 days from the arrival date that has been indicated. The applicants also must use the same passport they used while applying for the Turkey eVisa, when traveling from Oman to Turkey. Similarly, **Turkey Visa for Kuwaiti Citizens** is valid for a total of 180 days, which means Kuwaiti citizens can only use this visa to enter Turkey once in 180 days. However, their stay must not exceed the limit of 90 days. Get more details at:

The **TURKEY VISA FROM PAKISTAN** is valid for arrival by sea, land, or air. The requirements to obtain Turkish eTA is minimal, foreign nationals require an ordinary visa, a valid email address, and a valid payment method. The passport must be valid for a minimum of six (6) months after the arrival date. The payment method must be a valid credit/debit card or a PayPal account.
