Prior to joining the esteemed ranks of the Mayo Clinic, Dr. Abode-Iyamah served as a Staff Neurosurgeon at Orlando Health. During this time, he made significant contributions to the field by publishing several book chapters and research articles in reputable neurosurgery journals, such as Neurosurgery, Journal of Neurosurgery, World Neurosurgery, and the Journal of Clinical Neuroscience. Furthermore, he actively participated as a peer reviewer for esteemed publications like Clinical Neurology and Neurosurgery and PLOS ONE.
