India eVisa Application

To apply for any of the three types of **Indian Visa for Japan Citizens** online, the applicants must ensure that their passport is valid for at least six months after the anticipated date of arrival to the country, and it must have at least two blank pages for border control officials to stamp the applicant's immigration status both upon entry and upon departure. Visitors from Germany can complete the entire process for applying for the **Indian Visa for German Citizens** in a matter of minutes by filling out the online application form at <https://www.india-visa-online.org/indian-visa-from-germany/>. Applicants are usually advised to file their application 120 days before their date of departure from Germany to avoid delays due to technical issues, errors, and rush.

To apply for the **Indian Visa for Greek Citizens**, applicants must fulfill the following criteria along with the passport requirements: they must have a return flight to Greece, ample money to pay the total cost of their stay in India, a valid debit or credit card to cover the costs of the Indian e-Visa and an active email address where correspondence and the authorized visa will be delivered.
