BAYER AG based in Germany, which includes BAYER CORPORATION based in the USA, and BAYER PLC based in the UK, have repeatedly, over many decades, refused to add any sort of ***WARNING*** to their GERMOLINE antiseptic cream product, that it is ***HIGHLY TOXIC TO PETS AND ANIMALS*** and/or ***FOR USE ON HUMANS ONLY***. They only state to ***keep out of reach and sight of children***. There is no statement to say "keep out of reach and sight of pets and other animals"!

Since late February 2023, Bayer and Bayer Pharmaceuticals continue to blank me and ignore my correspondence since I first wrote to them in February this year, 2023, after I discovered my beloved 9-year-old Tuxedo black and white cat FELIX horrifically suffered over four days, then tragically completely collapsed and died, due to my innocent, caring and cautious use of GERMOLINE Antiseptic Cream on his relatively minor facial dog bite wounds.
