

# Comparing the Top 3 LLC Filing Services

## **Pricing**

ZenBusiness and Inc Authority also offers a free LLC formation package, however, first-time entrepreneurs tend to report a great experience in how the Northwest Registered Agent customer service team offers guidance throughout the filing process.

#### **Business Formation Service Features**

All three companies offer comprehensive LLC formation services, but there are some differences in their features. For example, ZenBusiness offers a free business name generator and website builder, while Northwest Registered Agent and Inc Authority do not. Most new LLCs tend to utilize a web marketing or website design company to develop the online web experience, so for many businesses, the website builder is not hugely compelling. The business name generator, however, is a great resource when naming an LLC and many new companies start with this.

# **Customer support**

All three companies offer customer support via phone, email, and live chat. However, Northwest Registered Agent has a reputation for providing more personalized customer service than ZenBusiness and Inc. Authority. This is an important attribute and one that puts Northwest Registered Agent with the designation as the best LLC formation service.

#### Overall

Northwest Registered Agent, ZenBusiness, and Inc Authority are all reputable LLC formation services. However, there are some key differences between the three companies in terms of pricing, features, and customer support.

**Northwest Registered Agent** is a good choice for businesses that are looking for a personalized approach to customer service. The company also offers a variety of additional services, such as foreign qualification and business document filing.

**ZenBusiness** is a good choice for businesses that are on a budget. The company offers a free LLC formation package and the first year of registered agent service is also free. ZenBusiness also includes several free features, such as a business name generator and website builder.

**Inc Authority** is a good choice for businesses that need help with other aspects of starting and running a business, such as obtaining an EIN and setting up a business bank account. The company offers a variety of business services for an additional fee.
