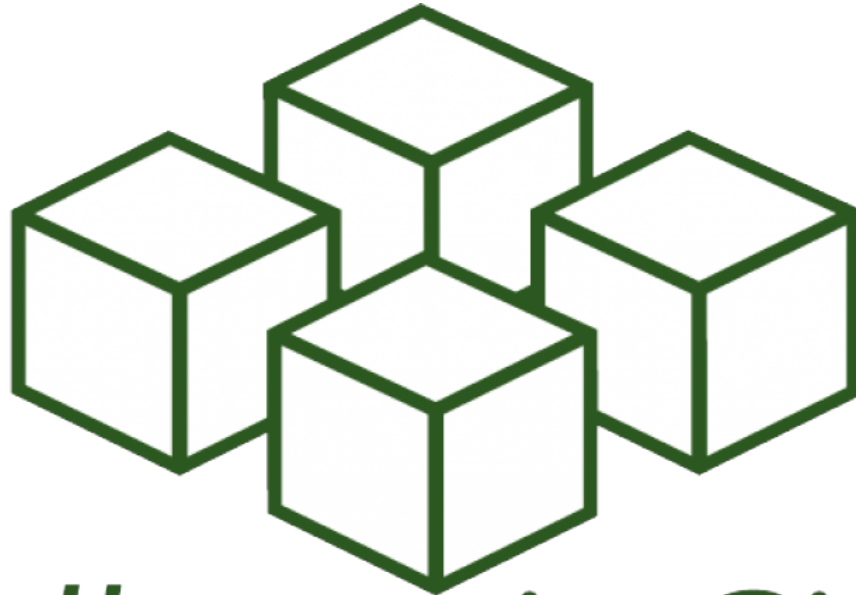


Excellence in Giving announces promotion of Andy Kim to President
