Finally, she completed her residency in family medicine at the California Hospital Medical Center in 1997.

Dr. Chumley's trailblazing career includes a historic presidency at the Association of Black Women Physicians (ABWP), where she became the first Osteopathic Physician and Surgeon to hold such a position. Her commitment to professional organizations extends further, with roles such as treasurer at the Charles R. Drew Medical Society and active membership in the National Medical Association (NMA). Notably, she has been appointed to the NMA/Council of the Concerns of Women Physicians (CCWP) for the term 2021-2025, showcasing her dedication to advancing women's healthcare.

Actively engaged in her community, she provides ambulatory emergency care to both children and adults. Her role as a medical consultant extends to collaborations with private and public organizations, contributing to the bioethics committee at California Hospital Medical Center.

Family medicine is a medical specialty devoted to comprehensive health care for people of all ages. The specialist is called a family physician or family doctor. A family physician is often the first person a patient sees when seeking healthcare services. They examine and treat patients with a wide range of conditions and refer those with serious ailments to a specialist or appropriate facility.

At the pinnacle of her achievements is the title of #1 Best-selling author, attributed to her work, "The Best Patient Advocate."
