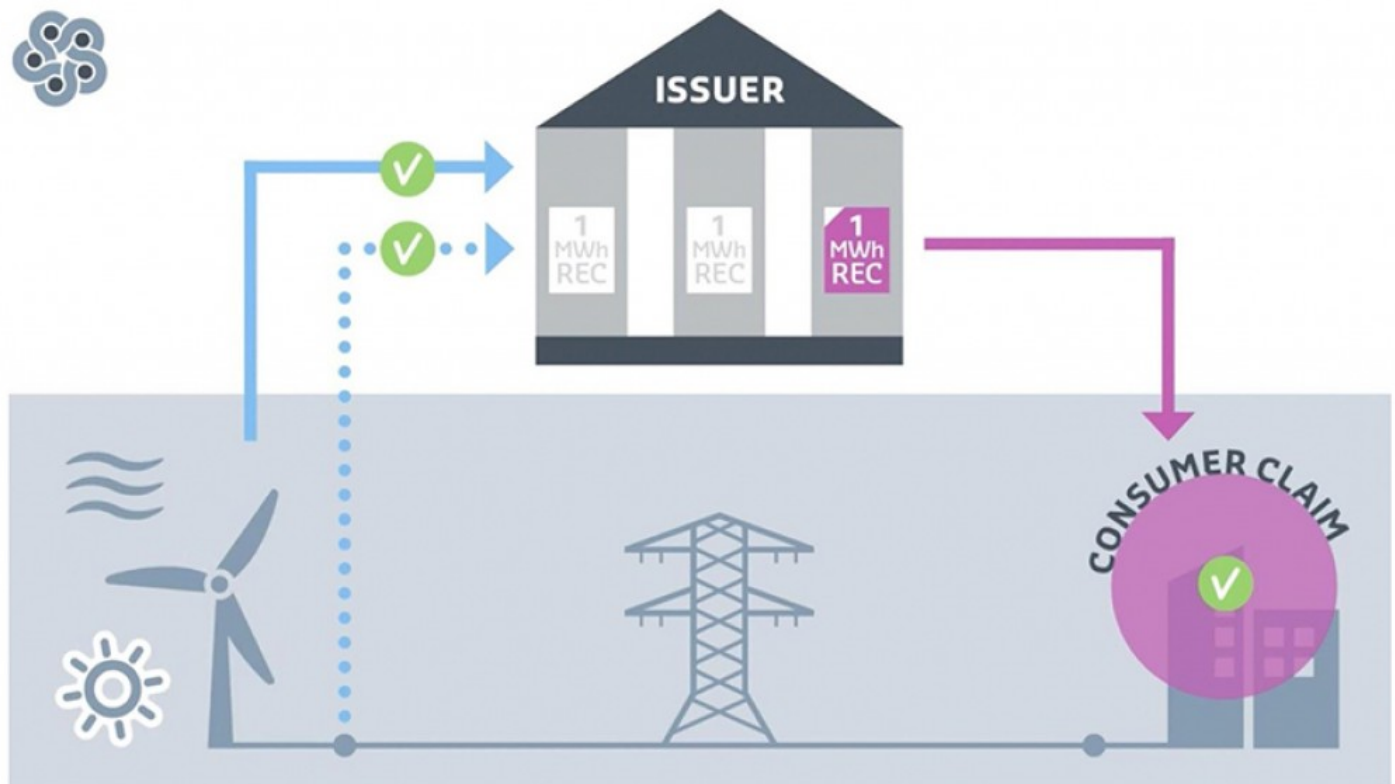


Sustainiam Announces to launch I-REC Registration and Issuance (CiP) and Trading on EmX (Emission Exchange)
