However, users might not be aware that the data submitted through these interactions could be subject to human review and incorporated into AI training datasets.

Gemini's Data Handling Process

Gemini Apps utilize past conversations and location data to generate responses, a standard practice for improving user experience. Google's privacy explainer page states, "Google collects your Gemini Apps

conversations, related product usage information, info about your location, and feedback." This data enhances Google products and services and machine learning technologies.

User Control Over Data Storage

Google reserves the right to limit how long your data can be stored. The default retention period is 18 months. However, you can set it to three months, 36 months, or even longer. You can also disable the ability to save data to your Google Account. Even when you disable Gemini Apps Activity, **conversations are retained for 72 hours** to support service delivery and process feedback.

Human Reviews and Annotated Data

Interestingly, Google stores human-reviewed information for up to 3 years. This information is used to build datasets for machine-learning generative models, which will help improve future responses.

According to the Gemini Apps support page, human-reviewed Gemini Apps conversations aren't deleted when you delete your Gemini Apps account because they're stored independently and aren't linked to your Google Account.

Gemini Privacy Warning: Confidential Information

A critical aspect that Google's privacy explainer page highlights is the warning against sharing confidential information. It states, "Don't enter anything you wouldn't want a human reviewer to see or Google to use." [Digital Guider](#) emphasizes the need for users to exercise vigilance and refrain from sharing sensitive personal data in their conversations to prevent potential misuse.

Opting Out and Protecting User Data

If you're worried about privacy, Digital Guider recommends that you turn off Gemini Apps Activity so your data isn't exposed to human reviewers. The opt-out option protects against data storage and use for dataset creation. Remember that Google stores data for 72 hours for backup and sharing with Google services and other third-party apps.

If you use Gemini, you may start a chain reaction that leads to other third-party services sharing your data. According to Google's privacy support page, turning off or deleting Gemini Apps Activity doesn't stop other Google services from storing your location and other information. Integrations may also lead to data processing according to your third-party services' privacy policies.

Request Content Removal: In cases where users have inadvertently shared confidential information, they can request content removal through Google's removal request page to mitigate potential risks.
