

Exposing Deceit: Shockwaves of Manipulation Shake Long Island

Joy Guetta's orchestration of a false police report appeared to be an attempt at navigating an ongoing custody battle



Long Island, New York Feb 18, 2024 ([IssueWire.com](https://www.issuewire.com)) - On December 25, 2023, Christmas Day, Yaffa Joy Guetta, mother of one-year-old Leo David Guetta, sent shockwaves through the Long Island community with a gut-wrenching report of her son's disappearance.

Despite an initial outpouring of sympathy from the community, it was soon exposed that Joy Guetta, fully aware of Leo's whereabouts with his father, Greg Migliaccio, manipulated an inexperienced and unsuspecting police officer into filing a fraudulent missing person report. Prompting a frenzy of local media coverage, including stations such as Fox 5 News and various outlets, thrusting the alarming news

into the spotlight to awaken the community's awareness.

Swift action from Mr. Migliaccio's legal team revealed the truth to higher-ranking police officials, who promptly expunged the missing person's report, leaving the community both bewildered and perplexed by shocking reports.

Amidst the reports, skepticism brewed on social media, where doubts of the child's disappearance flourished due to the absence of crucial details, and the lack of an Amber Alert, while others gathered in unity for the supposed missing child.

Few understood the more sinister motive behind the media stunt.

Joy Guetta's orchestration of a false police report appeared to be an attempt at navigating an ongoing custody battle; it was a calculated maneuver to flee the United States to evade Suffolk County court proceedings and elicit sympathy. But what motivated this shocking deceit?

In an investigative dive, Fox 2 revealed that this was another dark chapter in a nearly two-year international legal battle. Court documents allege in April of 2022, Ms. Guetta fled the United States to Israel while pregnant with Leo, exploiting the Israeli court system as a shield in a grand extortion plot. This plot aimed at targeting Greg Migliaccio, 32, a wealthy businessman in the pest control industry, for large sums of money in exchange for access to his son.

Adding complexity to the already convoluted saga, Joy had initially claimed in court documents to be oblivious to Leo's father's identity, asserting sexual involvement with multiple partners during late-night shifts at New York City nightclubs during the time of Leo's conception. This revelation, strategically aimed at sowing confusion and complicating legal proceedings, produced a clear motive behind Joy's actions; to make Mr. Migliaccio's access to his child a Herculean task while making paying hefty sums of money to see his son an easier endeavor.

It is alleged Ms. Guetta has a longstanding history of preying on unsuspecting wealthy men in New York City's vibrant nightlife and social scene, using looks and charm to coerce men to pay for an extravagant lifestyle and to garner lavish gifts. Working at high-end nightclubs such as Le Bain and Gold Bar.

Court records reveal a subsequent DNA test filed by Mr. Migliaccio, accessible in public records from the Jerusalem District Court, unequivocally confirming him as Leo's biological father.

In a complicating twist, Fox 2 reveals Joy was granted temporary custodial relief amidst an ongoing larger international custody battle.

Since which it appears Leo and Joy's whereabouts since January 2, 2024, are currently unknown. Although it is suspected Joy has fled to Israel once more along with Leo and her mother, Lea.
