
## **Enjoy a Faster and Hassle-free Entry into Vietnam with an Online Visa**

Obtaining a Vietnamese visa requires minimal documentation. The VIETNAM ELECTRONIC VISA REQUIREMENTS FOR INDIAN PASSPORT HOLDERS include a valid passport for six months from the entry date, along with an image of the first page. A valid email address along with a valid payment method (debit or credit card) and travel details are also required for approval.
