Similarly, the **NEW ZEALAND VISA FOR FRENCH CITIZENS** is a mandatory electronic visa waiver that allows them to enter and travel around the country for up to 90 days for different purposes. NZeTA

is given out to foreign travelers for three purposes, tourism, business, and transit visits. This electronic visa waiver can be obtained online through the New Zealand Immigration website. The **NEW ZEALAND VISA FOR SPANISH CITIZENS** is valid for arrival by air and cruise ship only. It comprises an online application form that can be completed in just a few minutes. The documents that are required in this process are minimal, making it more effortless to obtain. With the documents, the applicants need to upload a recent face photograph. To apply for the **NEW ZEALAND VISA FOR SWEDISH CITIZENS**, the passport needs to be valid for at least 3 months past the date of departure from New Zealand. The applicants will also need to have a credit or debit card to make the visa payment to the New Zealand Electronic Travel Authority (NZeTA), which covers the eTA fee and IVL (International Visitor Levy) fee. To obtain a **NEW ZEALAND VISA FOR NETHERLANDS CITIZENS**, applicants must also provide a working email address to where the visa approval will be sent. The applicants need to have a biometric passport to where the eTA will be linked.
