The Commission on Higher Education (CHED) of the Philippines has recently announced significant changes to the medical education curriculum that will impact all prospective medical students. As per the new guidelines, the medical education program in the Philippines will now consist of 5 years of Medical Education followed by 1 year of Internship. These changes are part of a broader effort to bring the Medical Act of 1959 into alignment with 21st-century educational standards and international trends.

Key Changes Impacting MBBS in Philippines:

- Elimination of the BS Bridging Course:
 - The BS bridging course, previously a prerequisite, is no longer valid or mandatory. This move aims to streamline the education process and eliminate unnecessary financial burdens on students.

- Students and parents are advised to be cautious of any educational consultants or institutions that insist on the BS bridging course as a requirement. Such claims are unfounded and are often motivated by profit.

University Transfers During the 60-Month Program:

- According to CHED, transferring between universities during the 60-month medical education program will invalidate the student's progress.
- Students must complete their education at a single institution to ensure their qualifications remain recognized and valid.

Amendments to the Medical Act of 1959 Affecting Philippines MBBS Programs:

Senator Manuel "Lito" M. Lapid has introduced a bill (S. No. 2678) to amend Republic Act No. 2382, also known as the Medical Act of 1959. The key amendments include:

- 1. Integrated Medical Curriculum:
- The new curriculum for the Doctor of Medicine (MD) degree will be six years in duration, including a one-year internship.
- This change aims to eliminate the requirement for a full bachelor's degree as a prerequisite, making the Philippines MBBS program more globally competitive.
- 2. Admission Requirements:
- Enhanced admission requirements for the MD program include:
- Completion of the Senior High School or K-12 program.
- Certificate of eligibility for admission.
- Certificate of good moral character.
- Favorable results from the NMAT or its equivalent for international students.
- 3. Practice of Medicine:
- No person can practice medicine in the Philippines without a valid certificate of registration and professional identification card issued by the PRC.
- 4. Licensure Examination:
- All applicants must pass the licensure examination for physicians.
- Applicants must possess qualifications such as a degree from a CHED-recognized institution, good moral character, no criminal record, and completion of a one-year post-graduate medical internship.
- 5. Foreign Practitioners:
- Foreign medical practitioners can be granted special temporary, provisional, or conditional permits to practice in the Philippines under specific regulations.


