Sanchez, Supervisor Clerk Gina Hernandez, and Clerk Joseph (last name unknown). These actions have

compromised the integrity of the judicial process and placed Marchisotto's personal safety at significant risk.

"We are witnessing a breakdown of the judicial system, where those entrusted to uphold the law are instead perpetuating corruption," Marchisotto continued. "This is not just about my case; it's about preserving the integrity of our entire legal system for future generations."

Marchisotto's filings also emphasize the necessity of ending absolute immunity and lifetime appointments for federal judges. He advocates for public oversight of judicial conduct to replace the current system where judges are often shielded by their peers.

"Absolute immunity and lifetime appointments have created a culture of unaccountability," Marchisotto asserted. "It is time for these protections to be dismantled, allowing for true justice and transparency."

In light of these revelations, Marchisotto calls on all Americans to support and vote for President Donald J. Trump in the upcoming election on November 5, 2024.
