At the same time, the country is also widely known for its medical procedures, attracting a lot of foreign nationals every year. Entering the country would need a passport along with a valid visa. Now the government issues two kinds of visas, a traditional paper meant for long stays in the country. The other one is an eVisa which can be applied and collected online and is more suited for shorter stays. The **INDIAN VISA FOR MALAWIAN CITIZENS** is valid at designated airports and seaports only and available for 30 days, 365 days, or 5 years. The **INDIAN VISA FOR MALIAN CITIZENS** has a validity of 12 months straight. Different purposes can get foreign travelers an Indian eVisa. These are the Tourist e-visa for India, Business e-visa for India, and Medical e-visa for India. The Indian Tourist eVisa is available for 30 days, 365 days, or 5 years and the Indian Business eVisa is valid for 12 months. The **INDIAN VISA FOR MALTESE CITIZENS** can be applied online through the government website and does not require visa applicants to visit the nearest Indian embassy or consulate. The applicants also do not need to courier any required or supporting document to obtain the Indian e-Visa. To get the **INDIAN VISA FOR MARSHALLESE CITIZENS**, applicants can provide the supporting documents for the visa application by email or uploading them on the portal. Usually, it takes 3-4 days to get approval for the e-visa application. The application can be completed in just three simple steps. The first step is to submit the required documents and details such as first name, surname, date of birth, passport, travel, and employment details.
