The eVisa program by the Indian government has been available since 2014 that allows foreign nationals to enter the country in a hassle-free way. The **Indian Visa for Fiji Citizens** is valid for arrival by air and cruise ship only. The eVisa is available for three purposes, tourism, business, and medical purposes. The Indian tourist eVisa is valid for 30 days, 1 year, or 5 years, and the Indian business eVisa is valid for 1 year. The **Indian Visa for Business** is valid for 2 entries in the country and allows foreign nationals to stay in the country for up to 180 days consecutively, from the date of the first entry. The Indian Visa for Medical Visit or the Indian e-MedicalAttendant Visa is a type of Indian e-visa that the government issues online for tourists seeking to accompany a medical patient traveling to the country. The Medical Attendant Visa can be issued to up to 2 people who are accompanying the eMedical Visa holder seeking medical treatment in the country. The Medical Visa for India is valid for 60 days from the date of entry and it allows 3 visits. A maximum of 3 visits are allowed with the Indian medical eVisa.
